However, the stress from this job proved too much, as I could not leave these very emotional cases at the office. At this point in my legal career, I got married and moved to the Dallas/Fort Worth area. Still determined to shift my focus toward serving the interests of the injured and vulnerable, I transitioned to becoming a plaintiff's lawyer at a premier national asbestos litigation firm. With unwavering determination and empathy for my clients, I learned how to fight relentlessly to secure justice for those harmed by exposures to dangerous products and toxic substances.

While I had to make one short detour from plaintiff's work back to defense work when we moved again, that deviation confirmed for me that my skills were best used advocating for people, not big business. I now clearly understood the devastating impact that negligence and corporate wrongdoing could have on people's lives. Drawing on my knowledge of the law and my genuine concern for others, I have dedicated almost the last 20 years to championing justice for these injured victims, seeking compensation for their pain, suffering, and losses.
